## **April is National Safe Digging Month**



Dating back over a decade, April has been recognized across the United States as National Safe Digging Month. Each April utility companies join together with the Common Ground Alliance (CGA) with the goal of raising awareness to safely excavate around buried utilities. Perhaps you have seen an area where colored marks have been spray painted on the ground or colored flags placed and wondered of the significance of the markings and colors. Well, wonder no more! Each color is specific to a particular utility service (See color chart below).

Whether you own a professional excavating company or you are a home owner getting ready to undertake a home project that requires digging, you must mark the ground where you plan to dig with white spray paint and then call 811 two

business days before you plan to dig and advise them of your digging plans (known as a Locate Request).

Once you have contacted
811, they will notify all of the utility
companies and advise them of your
plans to dig. Upon receiving the
Locate Request, utility companies are
given two business days to respond
and mark buried utilities. After completing the Locate Request, utility
companies are required to advise 811
that they have completed the Locate
Request and identified any buried

service line they have near your dig site. Once you have entered a Locate Request you may check the status by visiting the website www.nm811.org.

Once your Locate Request has been completed, you have 15 business days to complete the work. Once you begin the project, if you realize you won't be able to complete the digging in the allotted 15 days, that's no problem! Simply call

811 again two business days before the end of the 15 days and request a locate update. Calling 811 before you dig is free. It's easy and it's the law!

### You're almost ready to begin digging...

Now that all of your utility lines have been marked, it is important to understand that any digging that is done within 18 inches of either side of any of the marks must be done by hand (shovel) and still must be done with extreme care. In some instances, certain utilities may be buried only a few inches beneath the surface.

You may not use any mechanical device (backhoe, trencher, auger machines, rototillers, etc.) to dig within 18 inches of either side of the marks left by the utility companies.

This diagram illustrates the paths underground utilities might take to service your home. Imagine if you were going to install a picket fence around this home next weekend. Where would you place your white spray paint marks? If you planned on starting on Saturday, what day of the week should you contact 811 for the Locate Request? Exactly !! You should call on Wednesday.

## RECIPE

## **Grandma's Lemon Meringue Pie**

#### **INGREDIENTS**

Filling:

1 cup white sugar

2 tablespoons all-purpose flour

3 tablespoons cornstarch

1/4 teaspoon salt

1 ½ cups water

2 lemons, juiced and zested

2 tablespoons butter

4 egg yolks, beaten

1 (9 inch) pie crust, baked

Meringue:

4 egg whites

1/2 cup white sugar



#### **DIRECTIONS**

- 1. Preheat the oven to 325 degrees F.
- 2. To make the filling: Whisk 1 cup sugar, flour, cornstarch, and salt together in a medium saucepan; stir in water, lemon juice, and lemon zest. Cook over medium-high heat, stirring frequently, until mixture comes to a boil. Stir in butter.
- 3. Place egg yolks in a small bowl and gradually whisk in 1/2 cup of hot sugar mixture. Whisk egg yolk mixture back into remaining sugar mixture. Bring to a boil and continue to cook while stirring constantly until thick. Remove from heat; pour filling into baked pie crust.
- 4. To make the meringue: Beat egg whites in a glass, metal, or ceramic bowl with an electric mixer until foamy. Gradually add sugar, continuing to beat until stiff peaks form. Spread meringue over pie filling, sealing the edges at the crust.
- 5. Bake in preheated oven until meringue is golden brown, about 20 to 25 minutes.
